This set up provides only Service License (no trading licenses are given).

This special Virtual Office Business License does not require a local sponsor (it's a free zone license), it includes a hot-desk facility in a Dubai Business Center (prestigious location in Marina with ample parking and loads of restaurants and hotels in walking distance). The Free Zone provides up to 5 residence visa – (all other free zones offering this type of set up only provide for 1 or max 2 visa).

This extremely investor friendly Virtual Office Package licensed through a Northern Emirates Free Zone subsidiary (*fully approved by Abu Dhabi High Court!*) is the fastest, easiest and overall cheapest way to set up a business being domiciled in one of the best and highly developed locations in Dubai.

This set up will get you

- **Business license as FZ-LLC (limited liability company)**
- **Registered company name of your choice**
- **Option to open a bank account with any UAE bank**
- **Individual or corporate shareholder**
- **Up to 5 residence visa (incl. sponsoring of dependants)**
- **Package includes hot-desk and meeting room facility in a Dubai business center**

Approved activities are for example: Consulting, publishing, media/marketing services, filming, IT-services, broadcast management, music & entertainment, event management, information services

The free zone however is not too strict with categories and will listen to your needs (except trading).

Medical test for visa can be taken in a Dubai hospital. No need to travel to Northern Emirates to take the test.

** You get physical space with wireless internet access that you can use every work day between 9.00 a.m. to 6 p.m.*

Note: Most other Free Zones (Dubai, Abu Dhabi, Northern Emirates) have made above listed requirements mandatory and are thus much more expensive to set up with and procedures are more time consuming!

Comparison with Dubai Free Zones:

A full set up with office in one of Dubai's many Free Zones (such as TECOM, Jebel Ali, Airport Free Zone, Dubai Silicon Oasis, etc.) will cost a minimum of AED 80,000 – 150,000! In addition Dubai Free Zones all ask for share capital ranging from AED 50,000 to 1,000,000 depending on the company structure and request audited records after the first year of operation.

The specific Northern Emirates Free Zone offering this convenient Virtual set up operates directly in and out of Dubai and is legally approved by the High Court in Abu Dhabi.

None of the other Northern Emirates Free Zones has that competitive advantage of being approved by the capital of the UAE to legally operate out of Dubai!! So far that was exclusively reserved for Dubai Free Zones or Dubai sponsor set ups.

With Virtual set up you get an **official address in Dubai** and can use the business center hot desk (conveniently located in a prestigious area in Dubai Marina with easy access to and from Sheikh Zayed Road, and hundreds of restaurants and plenty of hotels at your fingertips and at walking distance).

The entire set up can be done without you having to travel to Dubai (if set up is done through an approved agent such as Global Office FZ-LLC.)

The Free Zone does not require any attestation for Virtual Office (except for branch office or if shareholder/owner is a corporation).

This is the easiest and fastest set up currently provided in Dubai – **no need to frequently travel** to any of the Northern Emirates Free Zones (which are 80 – 180 km distance from Dubai) to do a tedious set up with loads of paperwork involved or spend big budgets on Dubai Free Zone set ups.
